TERMS & CONDITIONS

Social Membership

Dear new Hollandse Club Member,

Please take note of the following Terms & conditions with regards to the Hollandse Club's Social Membership.

- The Membership period is for a minimum of 1 year, to be calculated from the day of the activation of the Membership which will be confirmed to you by email.
- During the aforementioned Membership Period, in accordance with articles 6i and 7.11 of the Hollandse Club's Rules & Regulations, the Member shall be classified as a Social Member.
- The Membership shall be automatically renewed on a monthly basis after the completion of the first 1-year period. After the first year, you may cancel the Membership at any time by giving a written notice thereof to the Hollandse Club's secretariat. In such case the cancellation of the automatic renewal will take effect 30 days after the Hollandse Club has received a written notice.
- After the Membership has ended, access to, and usage of the facilities of the Hollandse Club will no longer be allowed.
- You are 21 years of age or above and residing in Singapore.
- Each month you shall pay a subscription fee of SGD 150 (for single persons) or SGD 225 (for couples/families).
- Subscription fee may be altered by the Hollandse Club after the first year has ended.
- You shall pay a one-time administration fee of SGD 150 before the start of the Membership.
- You shall pay a one-time refundable deposit of SGD 700 (for single persons) or SGD 1,000 (for couples/families) before the start of the Membership. This deposit will be returned post settlement of your subscription fees and other dues following your resignation from the club.
- In case you resign from the Hollandse Club within the first year, you shall be obliged to pay the monthly subscription fees of the remaining months and all other debts due within one week from written notice of resignation.
- The Membership period is for a minimum of 1 year, to be calculated from the day of the activation of the Membership which will be confirmed to you by email.
- In the event you will relocate for a diplomatic reason within the first 365 days, you may terminate the Membership after 180 days given a one (1) month notice without incurring a penalty hereunder. In case you relocate from the Hollandse Club within the first 180 days, you shall be obliged to pay the monthly subscription fees of the remaining months (of the first 180 days) and all other debts due within one week from written notice of resignation.
- At the end of the Membership period the Hollandse Club will be entitled, without giving any prior written notice, to compensate any outstanding sums due to the Hollandse Club with the refundable deposit referred to above. In case the sums due to the Hollandse Club exceed the amount of the refundable deposit, The Hollandse Club will maintain its rights to claim such balance.
- Further to the above stated Terms & Conditions, the Social Membership is subject to the Hollandse Club's Rules & Regulations and Bye-Laws and any further amendments thereof.
