

## TERMS & CONDITIONS

1. Tentative bookings are held for 5 business days unless otherwise advised and confirmed at time of booking.
2. If confirmation is not received within the agreed time, the booking will automatically be cancelled and Hollandse Club reserves the right to rebook the venue and date.
3. The booking will only be considered as confirmed once the Agreement & Registration form is returned and the deposit paid.
4. All parties booked are based on a standard 3 hour block. Additional charges will apply for extensions based on an hourly rate.
5. Venue and entertainers are all subject to availability.
6. All party requests and details need to be finalised at least 14 days prior to your event.
7. The cancellation policy as per the table below will apply once a booking is confirmed.
8. Please note that the use of animals, fire and sharp objects (knives, spears, etc.) are not permitted within the Hollandse Club. This also applies to all entertainers and activities.
9. If Members bring their own entertainer/entertainment for the party, they are to provide full details of the entertainer at least 7 days prior to the event and must register the entertainer at reception on the day of the event.
10. Any package prices quoted below do not include Food & Beverage organised through Jaxs Bistro.
11. Storage and consumption of outside Food & Beverages are not permitted unless written approval is given.

## CANCELLATION POLICY UPON CONFIRMATION OF BOOKING

T > 30 days' notice .....	15%	7 - 14 days' notice .....	75%
15 - 29 days' notice .....	50%	0 - 6 days' notice .....	100% estimated amount is payable

Certain add-ons may have a non-refundable deposit to secure the item for your event irrespective of the notice period

## FOOD SUBMISSION POLICY

- Final event details need to be confirmed 5 working days before the event including final numbers and any dietary requirements.
- The number of guests charged will correspond to the number of guests provided on the final event details.
- If the number of guests is increased on the after this final confirmation, an additional charge per person will be applied.
- Payment for all food and service must be finalised on the day of the event.
